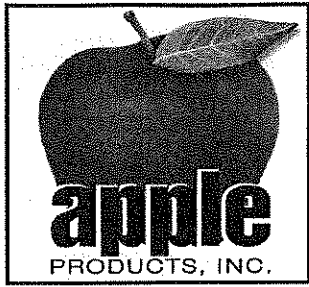

Section 4 First Aid

EMERGENCY OVERVIEW

Transfer contaminated absorbent, soil and other materials to containers for disposal.
