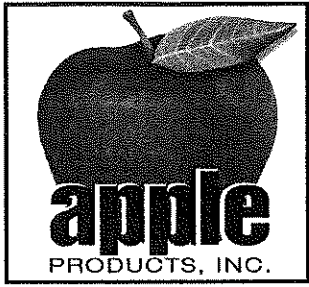

### Section 4 First Aid

#### EMERGENCY OVERVIEW
