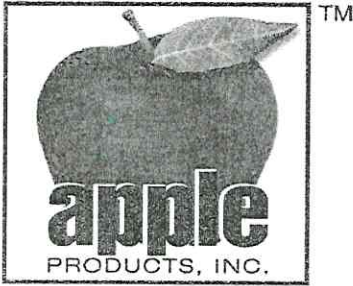

EMERGENCY OVERVIEW
